**RULES OF POVISIONS/ PROCEDURE**

- 1) The term of a member other than ex-officio member shall be four years.
- 2) The quorum for meeting of the Accreditation Committee shall be one half of the total number of members, a fraction counted as one.
- 3) The Accreditation Committee may co-opt any other member as per need.
- 4) The Chairperson or a member may not be removed from office before the expiry of the term except on proven charges of corruption, inefficiency, permanent disability or failure to attend three consecutive meetings without intimation in advance.

- 5) A meeting of the Accreditation Committee shall be held at least thrice in a financial year on such day, at such time and place as the Chairperson may determine.

### **FUNCTIONS**

The Accreditation Committee shall perform the following functions and make recommendations to the Punjab Higher Education Commission in respect of the following matters:

- a. Evaluate the feasibility for the establishment of new higher education institutes / Universities in the private Sector in the Punjab for grant of Degree Awarding Status and Charter;
- b. Addition of new faculties by the private sector higher education institutions;
- c. Matters relating to sub-campuses by the private sector higher education institutions;
- d. Grant of affiliation by the private sector higher education institutions;
- e. Monitoring, inspection and visitation into affairs of the higher education institutions;
- f. Cause monitoring and evaluation of the performance of the higher education institutions and process the accreditation matters of their sub-campuses, faculties, departments and disciplines as assigned to it by the Punjab Higher Education Commission and the Government from time to time; and
- g. Any other matter assigned to the Accreditation Committee by the Punjab Higher Education Commission and the Government.
