EXECUTIVE SUMMARY

Punjab Higher Education Commission (PHEC) was established under the PHEC Act, 2014 (I of 2015) as an autonomous public organization with the aim of improving the quality of Higher Education in the province and bringing it at par with modern needs.

In 2019-20, the Government of Punjab allocated a budget of Rs. 299.495 million for development activities. PHEC, within limited budget, has worked diligently towards increasing equitable access to higher education, promoting relevant research to furnish for the socio-economic needs of the province, catering to the professional development of faculty and staff of universities and colleges through its Staff Development Academy (SDA), providing scholarships for faculty of HEIs to ensure quality human capital and focusing on producing quality graduates to help build a knowledge economy.

In order to enhance access to quality higher education, PHEC prepared and obtained approval for various development schemes reflected in the Annual Development Plan (ADP) 2019-20. Additionally, projects pertaining to construction / updation of infrastructure of various HEIs were also reflected in the ADP 2019-20.

Recognizing the need for developing quality human resources, PHEC awarded various foreign and indigenous scholarships to faculty of public sector universities and colleges.

Moreover, in keeping with its mission to promote a culture of research in the province, PHEC funded faculty members of universities and public sector colleges to present their research work at various international conferences. It also provided funding to HEIs for organizing conferences and seminars.

PHEC also focused on bringing much needed structural reforms in public colleges through the expansion of its community/associate degree colleges initiative focused on producing market ready graduates.

To promote excellence in teaching and management in HEIs, PHEC Staff Development Academy (SDA) conducted trainings for college

PHEC's mandate includes provincially chartered 42 public and 26 private universities as well as 773 public colleges and 1632 private colleges.

To facilitate universities to serve as an engine of socio-economic growth in Punjab, PHEC is working with the HEIs, in accordance with the mandate and functions of the PHEC Act 2014, to yield the best results with its limited budget and resources.

Under the Annual Development Plan (ADP) 2019-20, following Universities and sub campuses were initiated

- (i) Kohsar University at Murree
- (ii) University of Chakwal
- (iii) University of Mianwali
- (iv) Thal University at Bhakkar
- (v) Sub-campus of Information Technology University at Rawalpindi

and university faculty to enhance their skills and subject knowledge. Senior management was also trained to equip them with necessary skills for effective leadership.

In the coming year, PHEC plans to expand these programs further and also introduce new initiatives. PHEC is working on the concept of establishing an Academy of Higher Learning to provide support and training to faculty and management of HEIs. Projects are also being initiated on expanding the Associate Degree program across the province as well as establishing smart classrooms in select colleges of Punjab. PHEC is committed to playing key strategic role in the development and implementation of the government policies and initiatives and supporting its efforts for the uplift of the higher education sector.

1. BRIEF INTRODUCTION

Punjab Higher Education Commission (PHEC) aims to improve the quality of Higher Education throughout the province. Punjab faces multi-dimensional challenges including lack of trained faculty, incompatibility of research outputs with socio-economic needs of the society and low priority to college education. Transformational and innovative interventions across all levels of the higher education sector are the need of the hour.

The central focus of PHEC is to enhance accessibility and affordability of opportunities in higher education for students across all socio economic segments. PHEC is committed to raising the standards of learning, teaching and research to stay competitive in the modern day economy as well as improving governance and management in HEIs for more efficient functioning.

It also aims to support the province's economic growth by creating a job-ready and employable workforce through emphasis on imparting structural and technical skills. PHEC is focused on strengthening efforts and expanding initiatives pertaining to quality assurance and quality enhancement, entrepreneurship and innovation to ensure the compatibility of educational outcomes with global benchmarks.

Finally, it is also focused to adopt proactive measures like technology commercialization, industry academia linkages and international collaboration to ensure meaningful reform in higher education sector in Punjab.

MANDATE

The Section 10 of the Punjab Higher Education Commission Act 2014 (Act I of 2015) empowers PHEC to:

- a) Coordinate with the Higher Education Commission in a result-oriented manner;
- b) Formulate guidelines and recommend policies in line with national standards prepared by the Higher Education Commission under which public and private institutions may be opened and operated in the Province;
- c) Prescribe guidelines and conditions under which institutions, other than universities and degree-awarding institutions, may offer qualifications in the higher education sector;
- d) Cause monitoring and evaluation of the performance of the institutions and carry out accreditation of institutions including their sub-campuses, outposts, faculties, departments, and disciplines through Accreditation Committee;
- e) Provide guidelines to ensure good governance and management of institutions to maintain high standards of higher education in the Punjab;
- f) Assist and advise the Government in quality enhancement and quality assurance of colleges;
- g) Cause third party performance audit of higher education institutions and furnish a copy of the results to the concerned body for corrective measures and follow up;
- h) Cause ranking of the higher education institutions of the Punjab;
- i) Submit to the Government precise grant in aid requirements of the institutions;
- j) Allocate funds to public sector institutions out of bulk financial provision received from the Government and other sources for such purpose on performance and need basis;
- k) Advise Institutions in raising funds from sources other than the Government;
- l) Support in creating of linkages between institutions and industry as well as national and international organizations that support research and development in higher education;
- m) Facilitate the introduction of educational and training programs that meet the needs of the market and promote the study in every field of national and international importance in the institutions;
- n) Ensure imparting marketable education and skills in the institutions and promote self-employment through entrepreneurship and small and medium enterprises;
- o) Advise institutions to ensure a proper balance between teaching and research;
- p) Undertake various faculty development programs for improving the quality of teaching and research in the institutions;
- q) Develop guidelines and facilitate the implementation of a system of quality assurance of institutions, based on the standards developed by the Higher Education Commission;
- r) Encourage, support and facilitate training programs, workshops and symposia at provincial and regional levels in public and private sector institutions;
- s) Prepare, in consultation with the institutions, plans for the development of higher education;
- t) Promote formal links between institutions to make the most effective use of expertise and specialized equipment and promote provincial, national and international linkages with respect to knowledge sharing, collaborative research, personnel exchange, and cost sharing;
- u) Take measures, including allocation of funds, for the award of fellowships, scholarships, travel and research grants;
- v) Establish endowment funds for higher education with contributions from the Government as well as non-governmental national and international sources;
- w) Collect such information and statistics on higher education and institutions as it may deem fit;
- x) Set up various committees consisting of provincial, national and international experts to advise the Commission on its affairs;
- y) Advise the institutions on the framing of subordinate legislation; and
- z) Perform such other functions as may be prescribed or as may be incidental to the discharging of the above functions or as may be assigned to it by the Government.

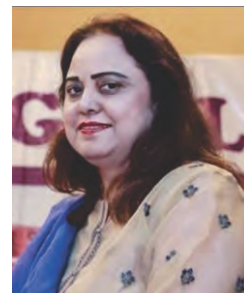

2. CURRENT STATE OF HIGHER EDUCATION

Economic development is contingent upon the improvement in human capital, and education, especially higher education. Higher education plays a pivotal role in building human resources. It is a powerful tool for building a modern, knowledgeable, and peaceful society that can lead the country towards a bright future. The United Nations' Sustainable Development Goal (SDG) 4 emphasizes to ensure inclusive, equitable access to quality education and promote lifelong learning opportunities for all citizens through tangible improvement in the education system of the country.

Universities in Punjab

Higher education refers to education above Grade 12 (Intermediate) which corresponds to level 5 of the HEC Qualification Framework. The higher education system, in Pakistan, is made up of two main sectors: the universities/Degree Awarding Institutes (DAIs) and Colleges. Punjab has a total of 68 universities/DAIs out of which 42 are in public sector and 26 in private sector.

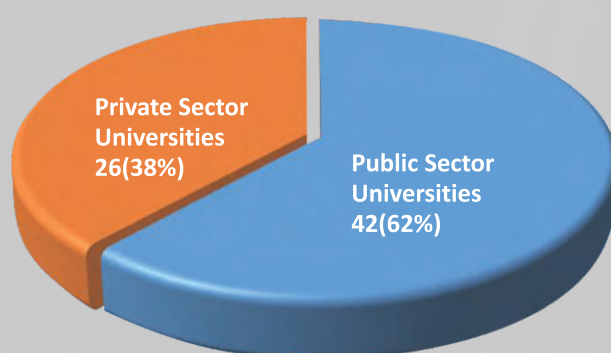


Figure 2.1: Chartered Universities in Punjab

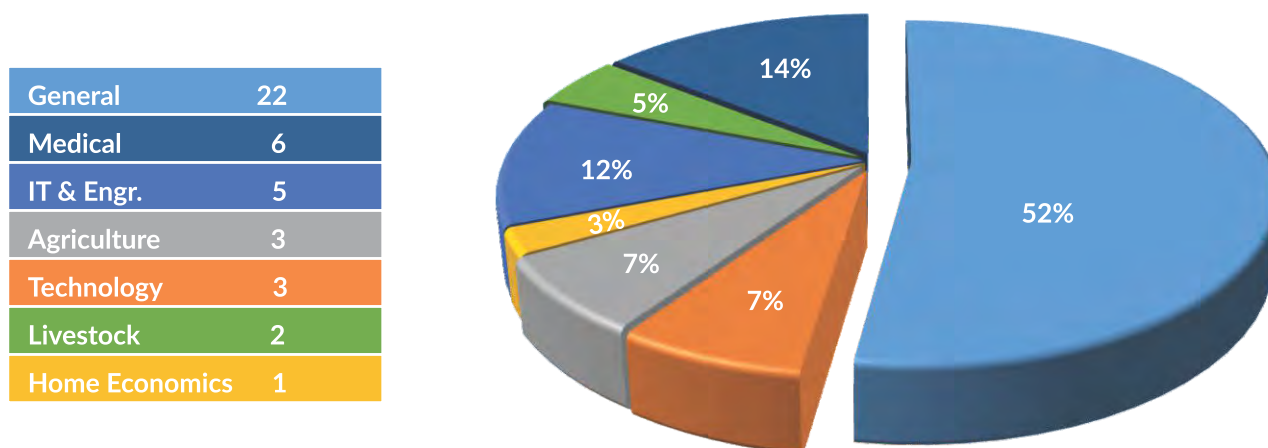


Figure 2.2: Category -wise distribution of Chartered Universities in Public Sector

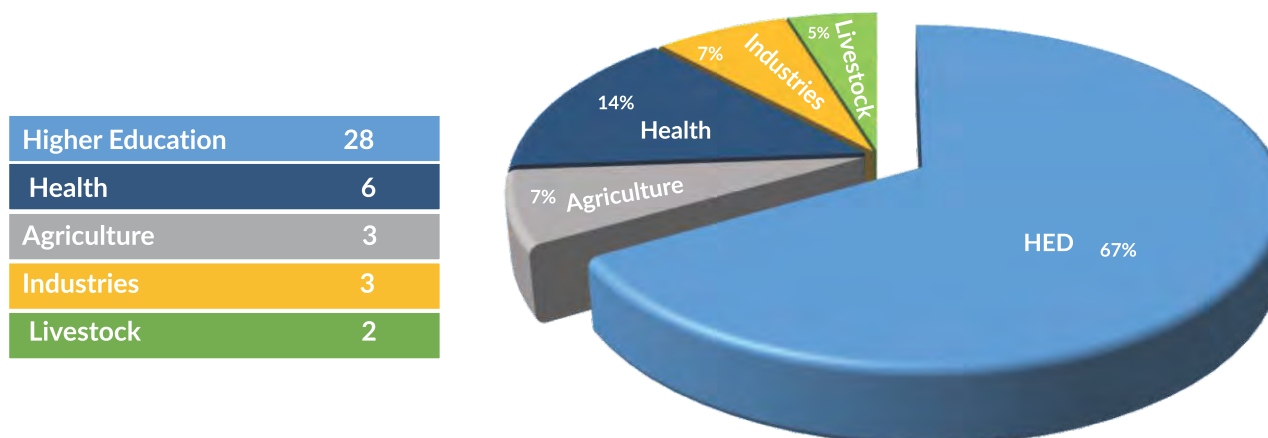


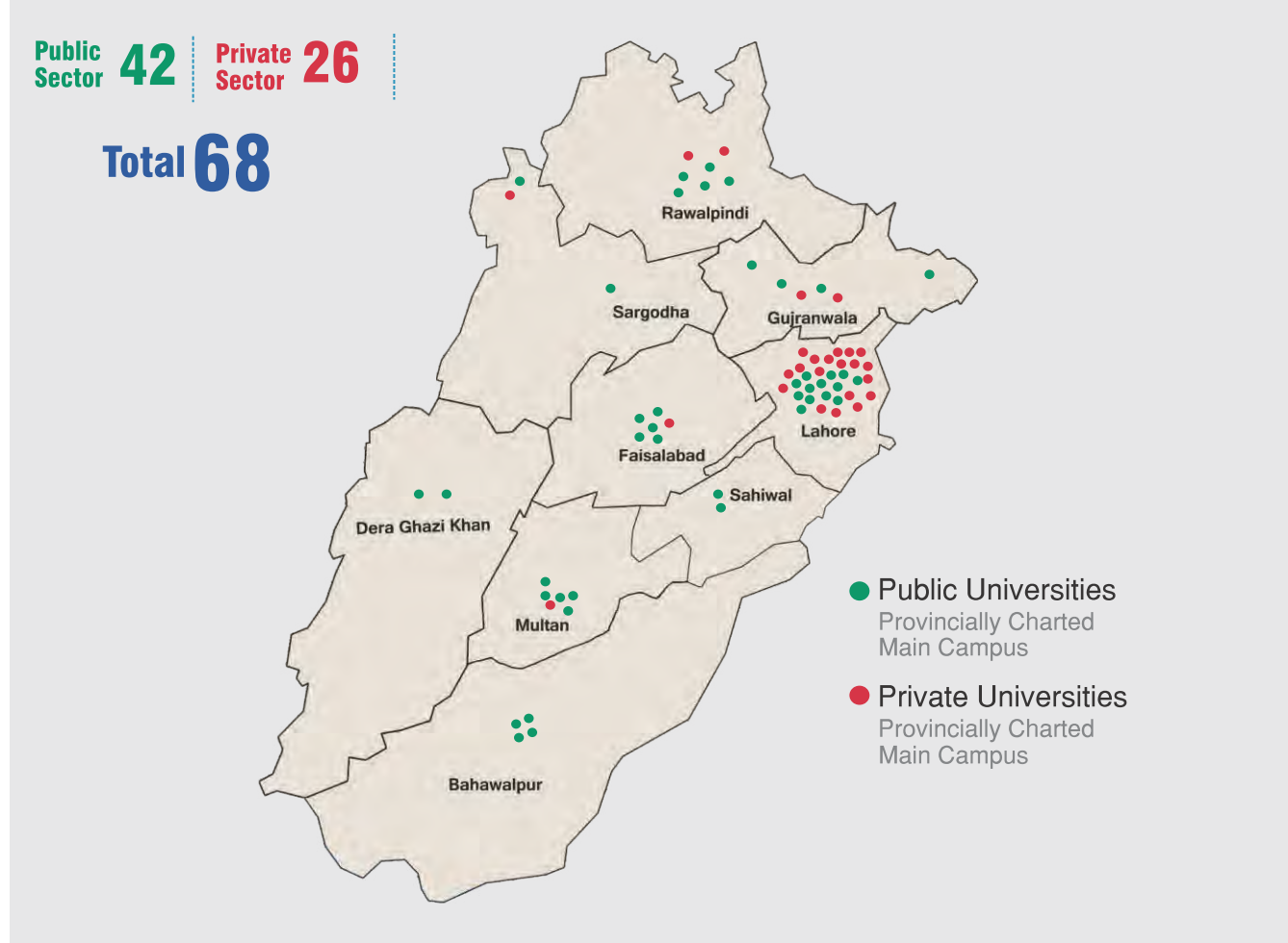
Figure 2.3: Department-wise Distribution of Universities in Public Sector

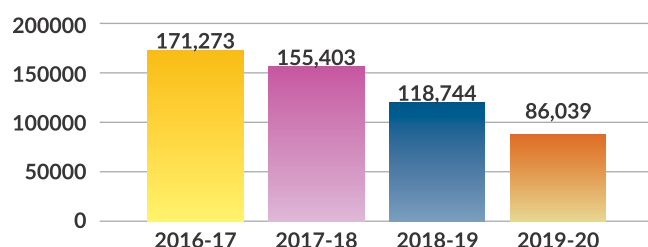


Figure 2.5: Enrollment in TEVTA Institutes in Punjab

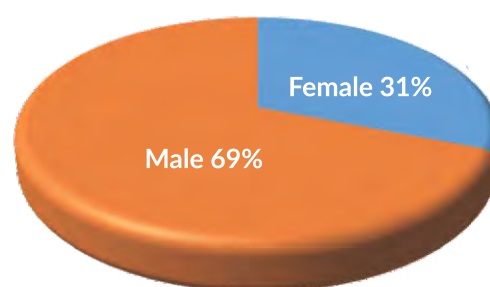


Figure 2.6: Gender-wise Enrolment in TEVTA Institutes

Figure 3.1: Budget Allocation for FY 2019-20

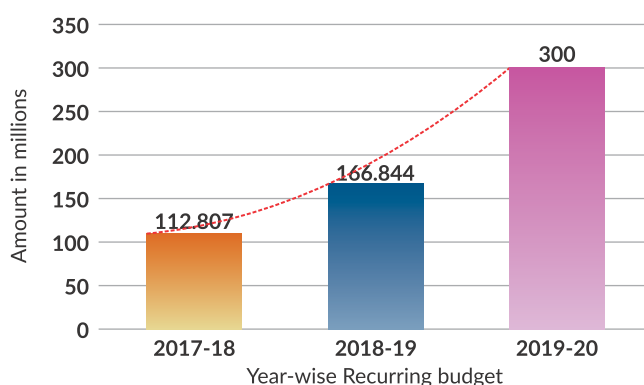


Figure 3.2: Year-wise Recurring Budget of PHEC

PHEC facilitates the Higher Education Institutions (HEIs) in the planning process which includes funding requirements, budget cycles and/or financial impacts, project phasing and anticipated future needs. The main objective of these activities is to establish and strengthen the HEIs, enhance students' enrolment and development of research facilities. For this, PHEC works in close liaison with various departments of the provincial government and Higher Education Commission (HEC). PHEC also oversees the development projects of higher education sector funded through the Annual Development Program (ADP), Government of Punjab.

Planning and Development department, Govt. of Punjab lists four key phases of the project cycle. PHEC plays a key role in all these phases.

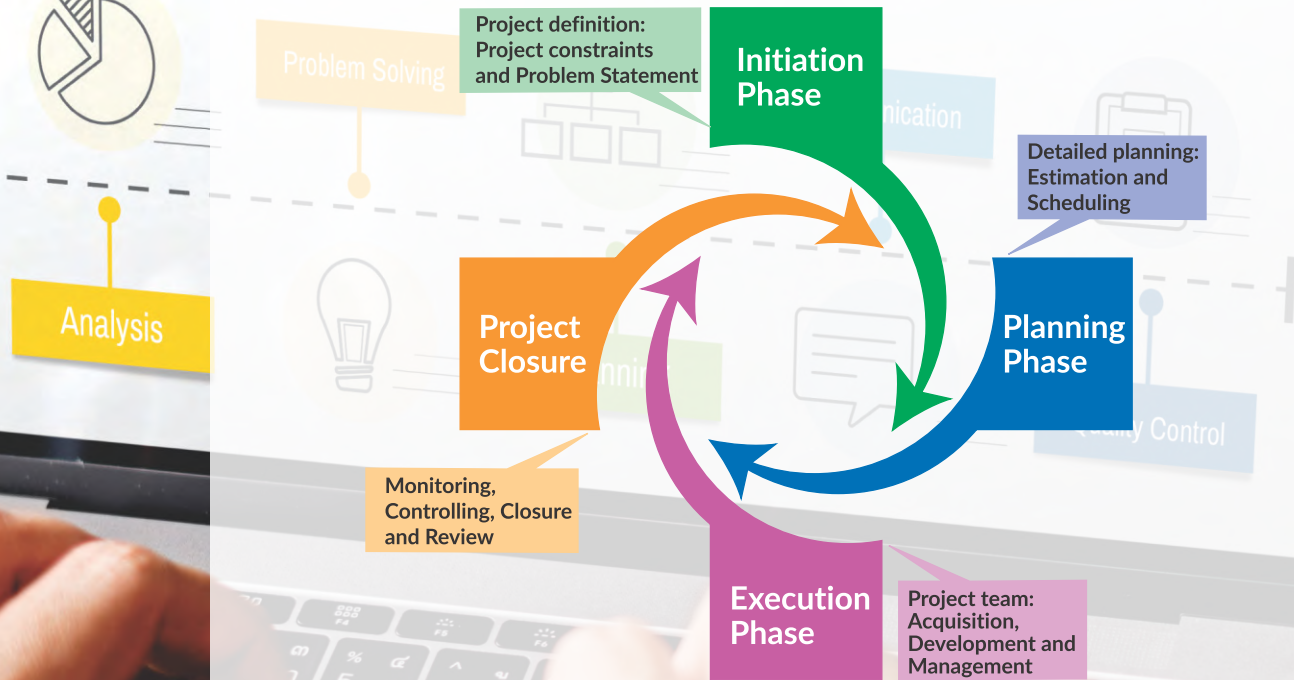


Figure 4.1: Project Management Cycle

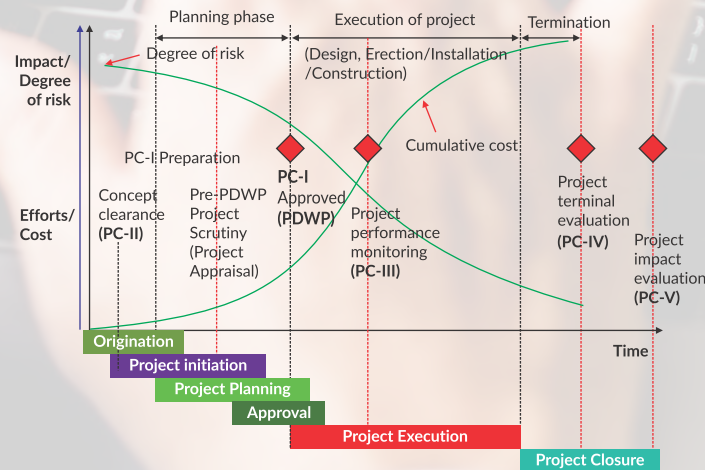


Figure 4.2: Process of Project Management

Preparation and Evaluation of Feasibilities for Establishment of New Universities

1. Baba Guru Nanak University at Nankana Sahib

PHEC prepared the master plan and civil work component for establishment of Baba Guru Nanak University, Nankana Sahib.

2. Thal University at Bhakkar

Government of the Punjab has planned to establish University of Thal at Bhakkar. In this backdrop, an onsite visit of the sub-campus of University of Sargodha at Bhakkar was conducted by PHEC and a feasibility report was prepared regarding up-gradation of the sub-campus of University of Sargodha at Bhakkar into University of Thal.

5. HUMAN RESOURCE DEVELOPMENT

Punjab Higher Education Commission (PHEC) under the PHEC Act, has the mandate; i) to undertake various faculty development programs for improving the quality of teaching and research in the institutions, ii) take measures including allocation of funds to award fellowships, scholarships, and to facilitate organizing conferences, seminars and symposia in the institutions of higher education (public and private sector universities and public post-graduate colleges) in order to promote a culture of research.

PHEC has launched various programs to improve the research and teaching skills and to equip the faculty with required knowledge in line with the modern trends. In 2019, the following projects were administered through HRD:

- a) Foreign PhD Scholarship Program
- b) Split PhD Scholarship Program
- c) Foreign Post-Doctoral Fellowship
- d) Indigenous Post-Doctoral Fellowship

Foreign PhD Scholarship Program

In order to enhance the capacity of faculty members of public sector universities and colleges, PHEC introduced a fully-funded Foreign PhD Scholarship Program. A total of 22 faculty members are currently pursuing their doctoral studies in various prestigious universities of the world.




Figure 5.1: Country-wise Distribution of Scholars (N=22)

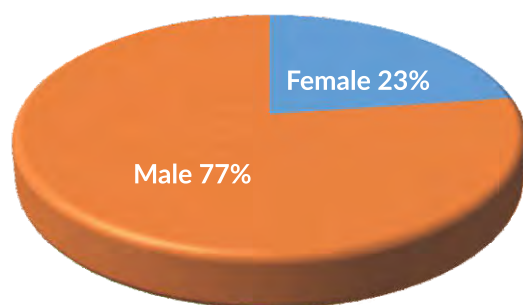


Figure 5.2: Gender-wise Distribution of Scholars (N=22)

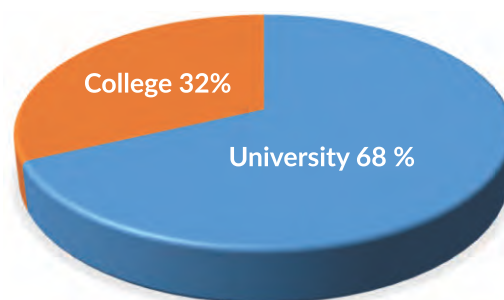


Figure 5.3: University/College-wise Distribution of Scholars (N=22)

Split PhD Scholarship Program

In order to provide a diverse learning experience to faculty members of public sector universities/colleges, PHEC offers a Split PhD Scholarship Program. This program is meant to bring quality in the local PhD programs and provide international research exposure to scholars. The program offers scholars the opportunity to take up research work in top ranked foreign universities under the supervision of an advisor/supervisor from the relevant field of study. Currently, PHEC has signed Memorandum of Understanding (MOU) for this program with four universities i.e. University of the Punjab (PU), Government College University (GCU), Lahore, University of Education (UoE), Lahore and University of Gujrat (UoG). In 2019, PHEC funded a total of 17 scholars under this program:

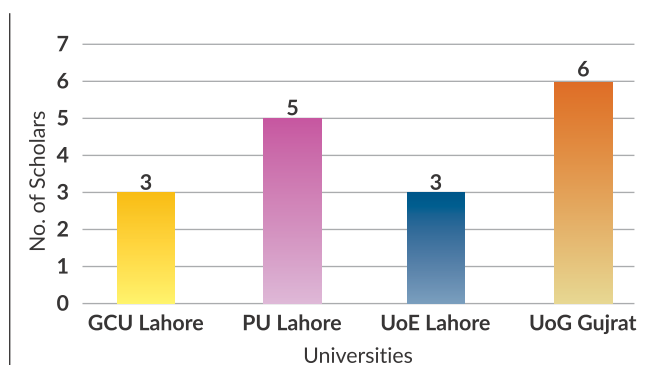


Figure 5.4: University-wise Distribution of Scholars (N=17)

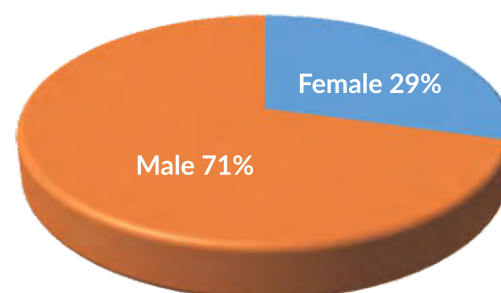


Figure 5.5: Gender-wise Distribution of Scholars

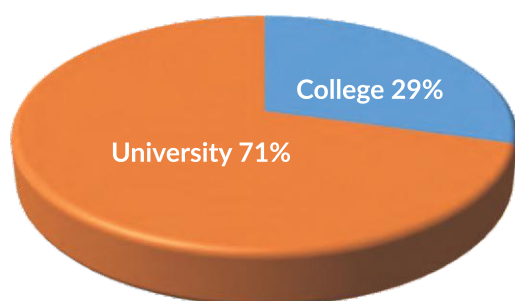


Figure 5.6: University/College-wise Distribution of Scholars

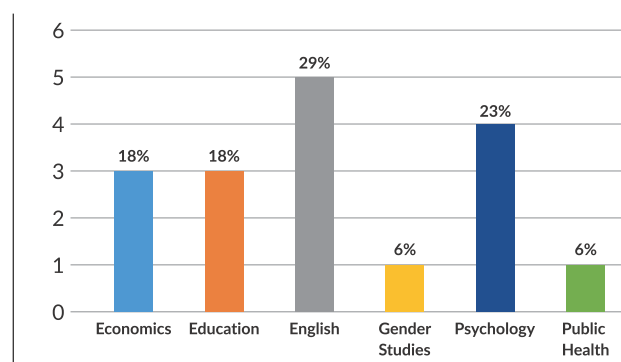


Figure 5.7: Subject wise Distribution of Scholars (N=17)

Foreign Post-Doctoral Fellowships

PHEC provides one-year Foreign Post-Doctoral Fellowships to faculty members of public sector colleges and universities to further their teaching and research skills. The program not only provides opportunity of research work in top ranked universities abroad but also helps to strengthen international collaboration and networking with foreign scholars and researchers, and helps to engage stakeholders in collaborative projects of mutual interest.

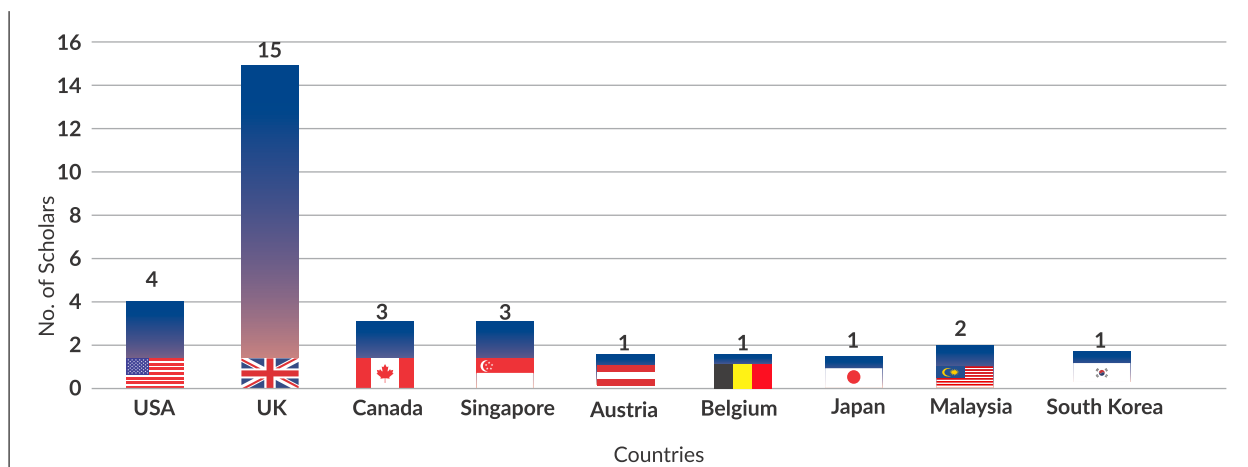


Figure 5.8: Country-wise Distribution of Scholars (N=31)

In 2019, a total of 31 faculty members completed their post-doctoral fellowships abroad. Country-wise detail is given in Figure 5.8.

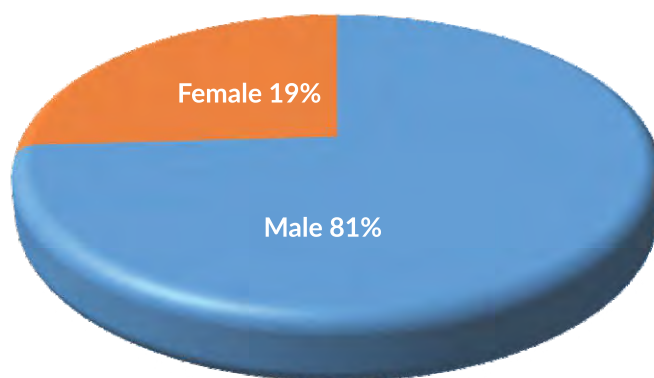


Figure 5.9: Gender-wise Distribution of Foreign Post-Doctoral Fellowships (N=31)

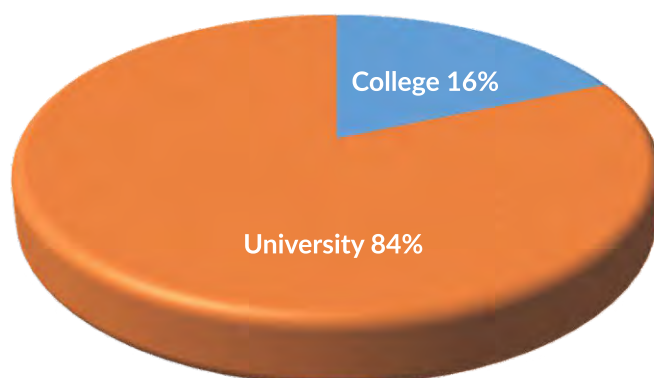


Figure 5.10: College/University-wise Distribution of Foreign Post-Doctoral Fellowships (N=31)

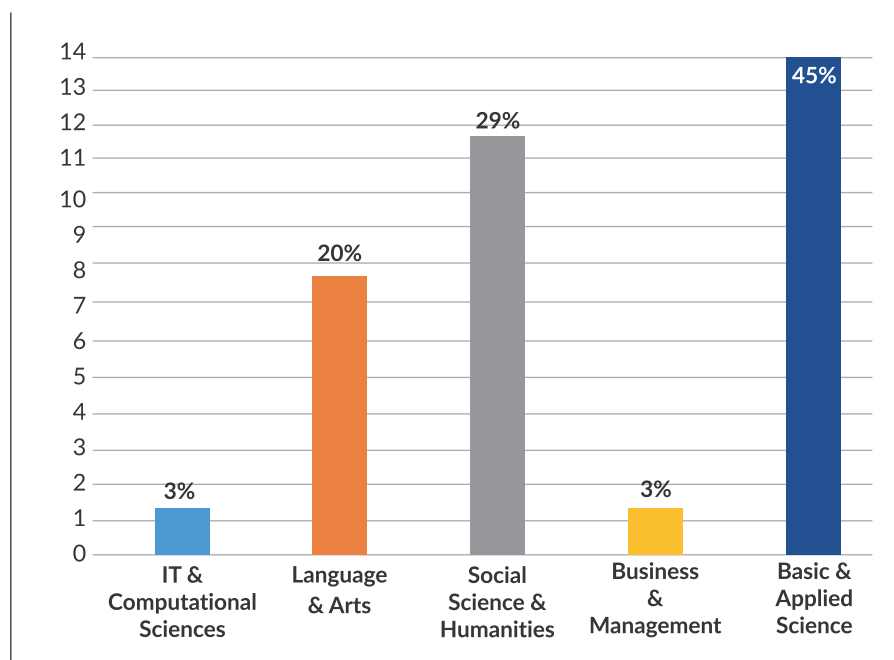


Figure 5.11: Subject-wise Distribution of Scholars

Indigenous Post-Doctoral Fellowship Program

Indigenous Post-Doctoral Fellowships are being offered to train faculty members who, for various reasons, are unable to avail foreign post-doc fellowships.

This program was split into two phases:

Phase I: Selection of Research Supervisor and Award of Research Grants

Phase II: Selection of Post-Doctoral Fellows/Researchers

In the first phase, the research supervisors were identified. For this purpose, PHEC invited applications/proposals for Research Grants for Indigenous Post-Doctoral Fellowships (12 months) from senior faculty members having PhD in social sciences through their respective institutions. The PHEC Research Grant Selection Committee selected twelve (12) research supervisors through a rigorous evaluation process.

In the second phase, "Indigenous Post-Doctoral Fellowships" were advertised and applications were invited against the selected research proposals. Short-listed candidates were interviewed by Committee headed by the research supervisor selected in the first phase. PHEC awarded twelve (11) Post Doc Fellowships.

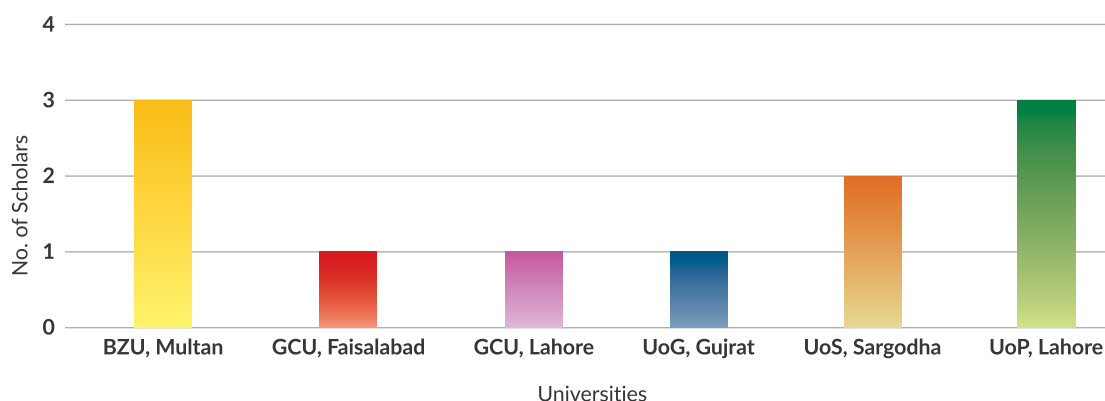


Figure 5.12: University-wise Awards of Fellowships (N=11)

6. PROMOTION OF RESEARCH

Punjab Higher Education Commission (PHEC) has been mandated to encourage, support and facilitate workshops and symposia at provincial and regional levels in public and private sector institutions and promote a culture of research in HEIs. It is entrusted to take measures, including allocation of funds for award of fellowships, scholarships, travel and research grants.

International Travel Grants

PHEC has initiated various programs for promotion of research. International Travel Grants (ITGs) is one such initiative, which aims to equip faculty members, non-teaching staff and PhD scholars of HEIs with worldwide exposure and provide them better opportunities to make international linkages and collaborations. ITGs also enhance the research culture in Punjab through acknowledging and promoting the work of researchers by facilitating them to present their research findings at international forums.

In 2019 11 travel grants were awarded on merit and covered:

- Registration fee of the event
- Airfare
- Accommodation charges
- Daily living expenditures as prescribed

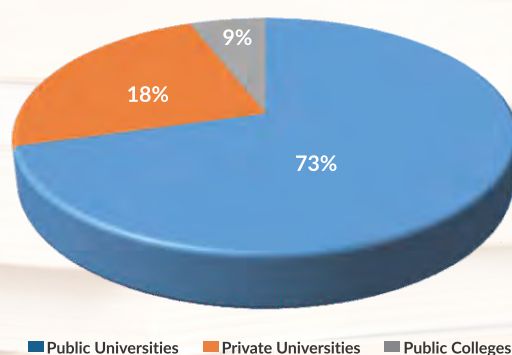


Figure 6.1: HEIs-wise Distribution of ITGs awarded in 2019 (N=11)

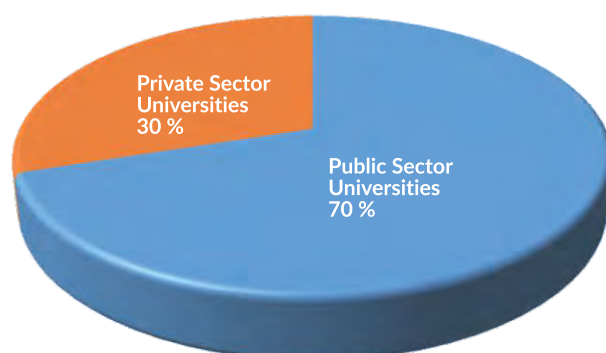


Figure 6.2: Sector-wise Funding for Conferences (N=20)

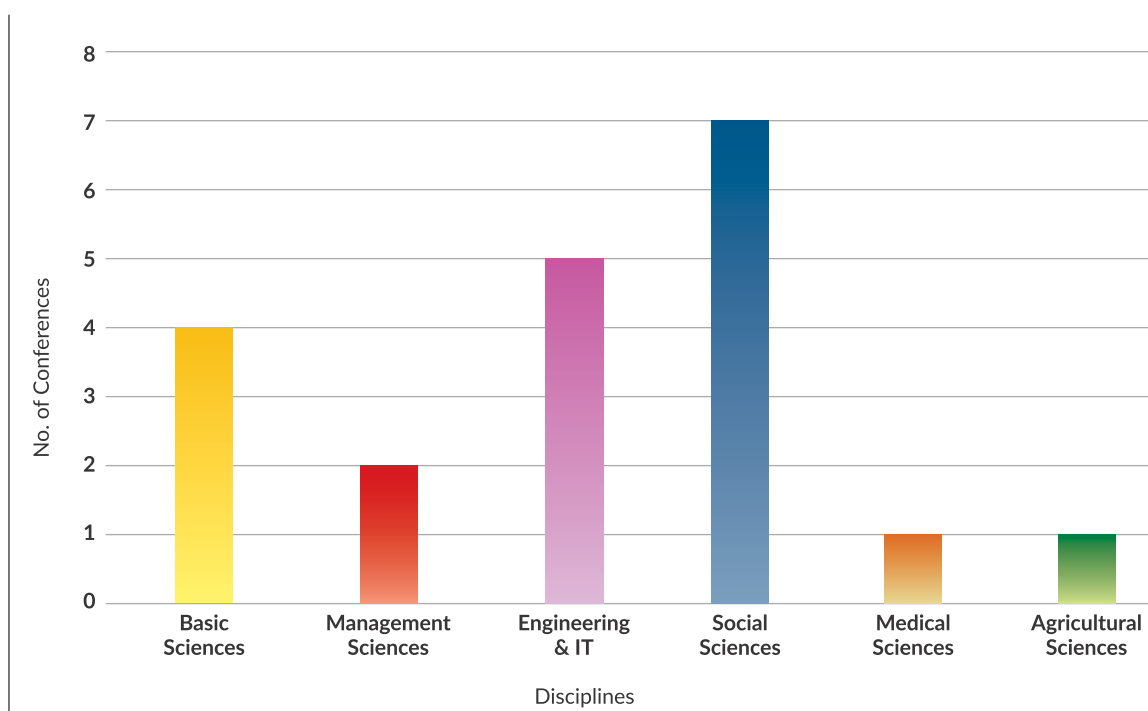


Figure 6.3: Discipline-wise Funding for Conferences (N=20)

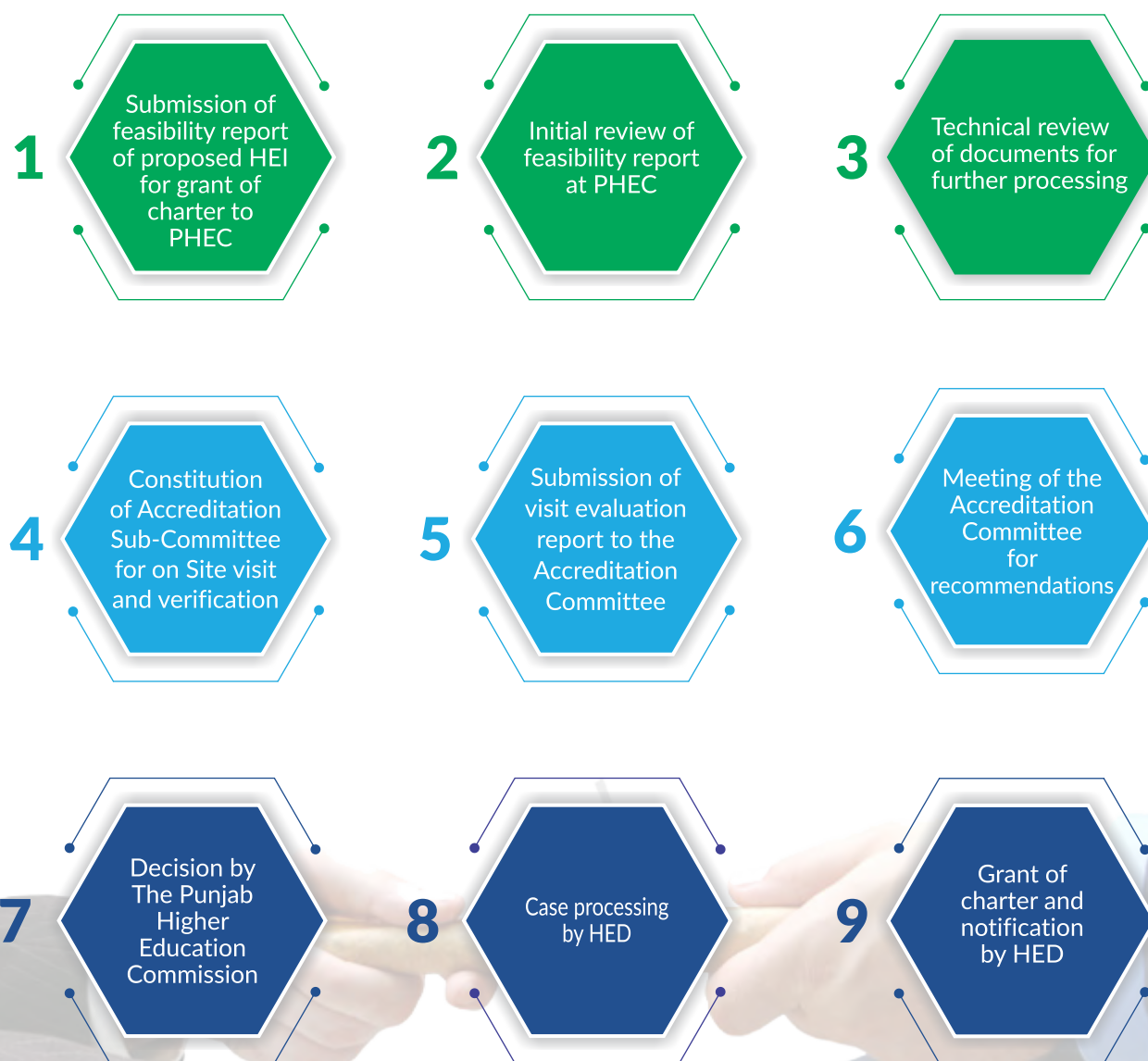


Figure 7.1: Flowchart of Approval Process for Charter of HEIs

PHEC considers the private sector as a key stakeholder in achieving the goal of increased access to higher education. The basis of the yardstick for evaluating the requests of private sector HEIs are the provisions enlisted in their respective Charters and the policy of Government of Punjab.

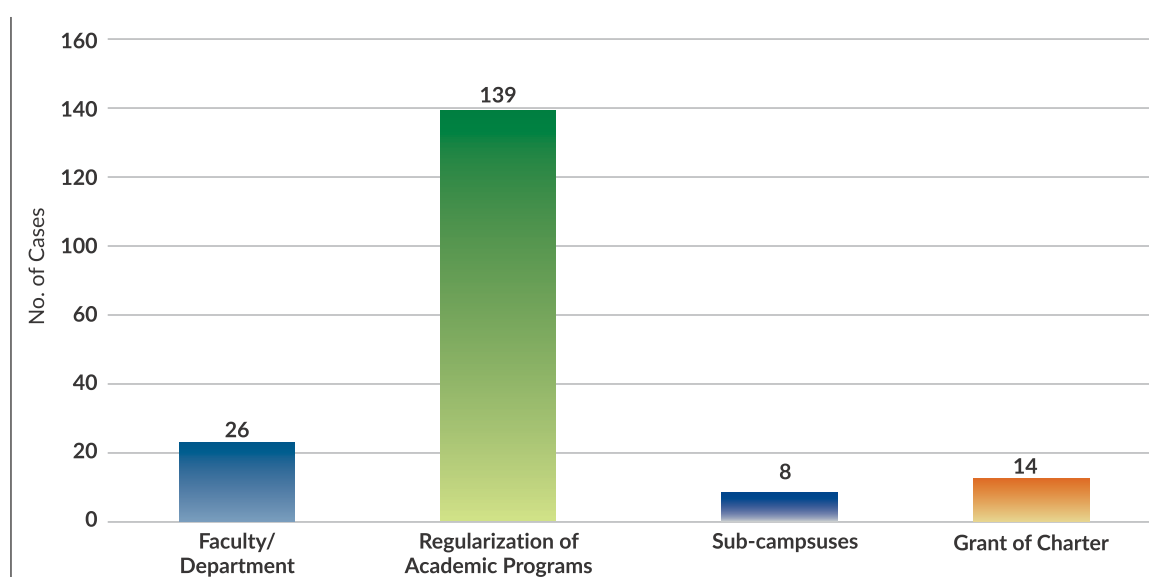


Figure 7.2: Evaluation of Cases in 2019



8. CAPACITY BUILDING AND PROFESSIONAL DEVELOPMENT

Internationally, there has been a transformation from universities' traditional role of teaching to entrepreneurship and knowledge generation in order to support knowledge-based economies. This has led to a need for a leadership comprising professionals with multi-faceted capabilities including an understanding of academic and research matters, financial management as well as administrative skills. Similarly, quality teaching is widely considered as the foundation of quality education. In order to bring about the desired learning outcomes and to educate students who can compete in today's global economy, it is essential that teachers acquire the necessary subject knowledge, andragogical/pedagogical skills and core values.

PHEC has taken various steps to improve the capacity of faculty, staff and management of universities and public sector colleges of Punjab. PHEC, with the support of Higher Education Department (HED), established its Staff Development Academy (SDA) with a mission to offer capacity building programs for faculty and staff. To support this initiative, a PC-I entitled "Faculty Pedagogy Skills Program" worth Rs. 176.087 million was approved in FY 2016-17 for three years by the Government of the Punjab. PHEC signed an MoU with University of Education to house the academy at the university along with the provision of residential facility for trainees.

The strategic objectives for the establishment of the SDA include:

- Provide a permanent platform for the professional development of faculty and staff of public sector colleges and universities in Punjab.
- Design relevant training interventions (Induction, Promotion, General and Specialized Training Programs) for university and college teachers and management.
- Provide international capacity development opportunities to college faculty in Punjab.
- Provide long term support to entire ecosystem of innovation in the province by offering Continuous Professional Development Programs that are relevant to the market needs.

Through this PC-I, by 2019, PHEC has trained 1430 teachers/management of colleges and universities in 29 batches including Induction Training of newly hired Lecturers and Assistant Professors. The PC-I has been revised with a new target to train 2500 teachers locally and 50 teachers internationally through University of Leicester, UK.

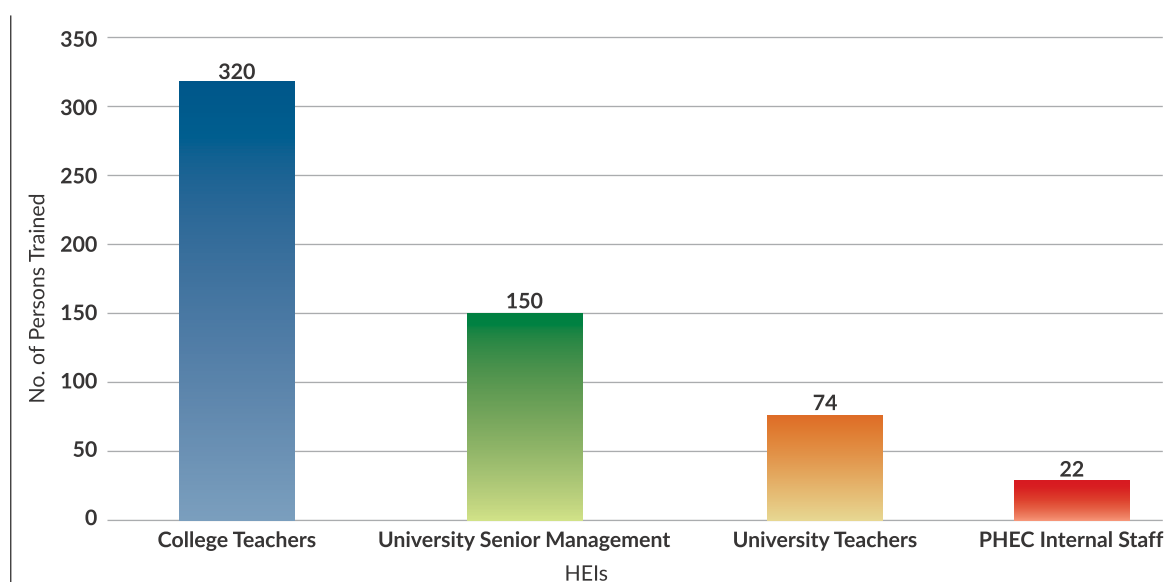


Figure 8.1: HEI-wise Participation in Training Programs

9. SPECIAL INITIATIVES

Education is an important factor in the socio-economic development of a country. At a global level, new approaches are being introduced in teaching and learning arenas. Standards of quality education have become more refined. The focus of the world is now on the skills that meet the emerging needs of both the local market as well as the global market. In order to match the pace of global economic development, it is very exigent to reform our education system at par with global standards.

PHEC envisions to ameliorate the quality of the higher education sector and bridge the gap between industry and academia by introducing structural reforms in this sector. For this purpose, PHEC has a mandate to improve the deficiencies in the existing educational system through formulating suitable policies.

Expansion of BS - Four Year Program at College Level

The BS Program is an internationally standardized degree program that was initially launched in 26 colleges of Punjab in 2010 and later expanded to 43 colleges. In order to improve the quality of the BS program, an evaluation of 43 public sector colleges offering BS 4-year Program was done by PHEC to ascertain the issues related to quality. The results of the study are as under:

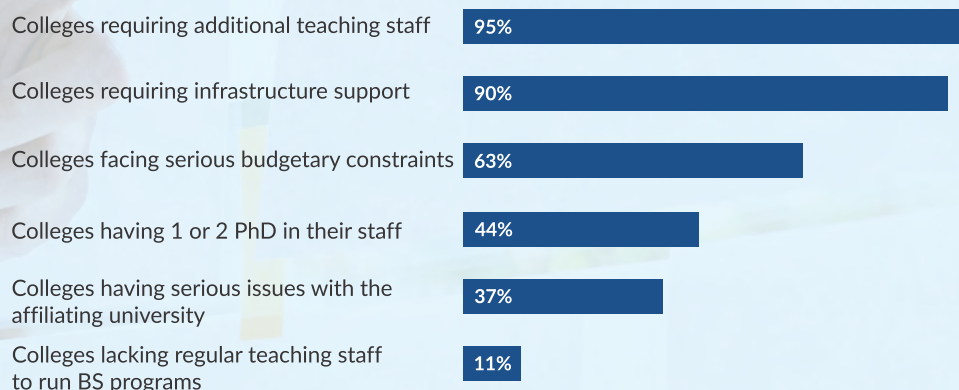


Figure 9.1: BS Program Quality Related Issues (N=43)



The results of the study were shared with HED, Government of Punjab.

In order to expand the BS 4-year program in selected public and private sector colleges across nine Divisions of Punjab, PHEC, following the notified criteria of HED, Government of Punjab, processed the cases of 91 public sector colleges and 69 private sector colleges.

Community/Associate Degree Colleges

In Pakistan, the youth population accounts for more than 50% of the total population. From amongst those with access to higher education, a large proportion is enrolled in the traditional 2-year annual BA degree, offered in the 750+ public sector colleges of Punjab, which is outdated and has little or no market value. The prevailing high unemployment rate is strongly related to the lack of connection between the degrees being offered and the required human resource.

The Community College Model, providing higher education and lower-level tertiary education, and granting certificates, diplomas and associate degrees to develop well-trained and certified workers, has been implemented with great success across USA, UK and other nations. Community colleges offer high quality education with technical expertise at low cost and in a flexible manner. The focus is on developing marketable and industry-driven skills in the graduates to fulfill the dearth of skilled human resource in various arenas of industry.

In this perspective, the PHEC with the support of the HED, Govt. of Punjab launched a Community Colleges Pilot Program in Punjab with the following objectives:

- i. Provide low-cost quality education.
- ii. Introduce market-driven subjects in the college sector in line with industry and society's needs.
- iii. Create a professional workforce that has high employment value.
- iv. Increase access to higher education by providing opportunity to students to earn degrees in employable areas of study at an affordable cost.
- v. Bring about a structural reform in the college sector to improve quality of education.

In the first phase of the pilot program, four colleges (02 male, 02 female), from four of the nine divisions of Punjab (Lahore, Faisalabad, Multan, Gujranwala), were selected and subsequently notified by the HED, Govt. of Punjab. In 2018, five additional colleges from the remaining divisions of Punjab were also included.

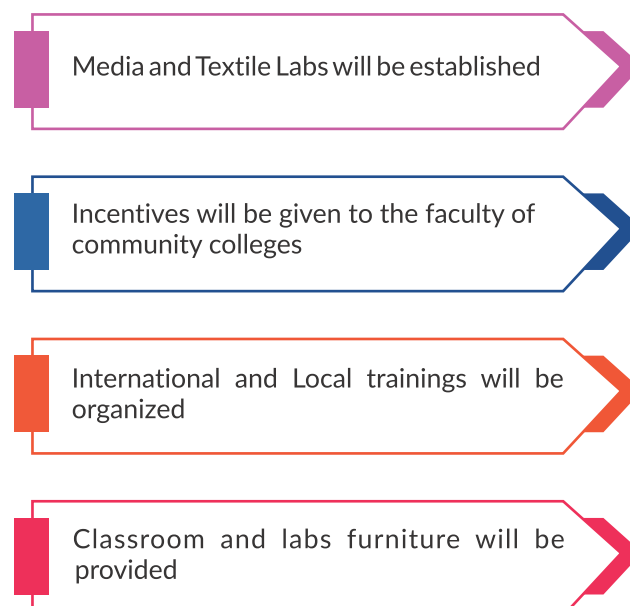


PHEC adopted several measures to ensure the smooth functioning of the program. The following support has been provided to community / associate degree colleges till now

International & Local Training for Faculty & Staff

Establishment of Career Counseling Centers in four colleges with the objective of organizing workshops, seminars and industry tours to form a link between classroom learning and real life activities.

In ADP 2019-20, the second phase of the initiative entitled “Expansion of Community Colleges” has been approved through which Community Colleges in the remaining 27 districts of Punjab will be established.

Furthermore, in 2019, PHEC organized a joint meeting of HEC, HED, and Vice-chancellors of public sector universities under the convenorship of Minister for Higher Education, Punjab, for phasing out the two-years BA/BSc on the annual system and their replacement with the Associate Degree program on the semester system. PHEC is working with all stakeholders for the implementation of this policy decision by the Govt. of Punjab. PHEC has also prepared curriculum templates in the following areas to be used as exemplars by universities for adoption or restructure keeping in view their specific requirements.

- i. Associate Degree (AD) Program in Computer Science
- ii. Associate Degree (AD) Program in Computer Networking & Infrastructure
- iii. Associate Degree (AD) Program in Database Management System
- iv. Associate Degree (AD) Program in Web Design and Development
- v. Associate Degree (AD) Program in Cyber Security
- vi. Associate Degree (AD) Program in Robotics and Artificial Intelligence
- vii. Associate Degree (AD) Program in Hotel and Restaurant Management
- viii. Associate Degree (AD) Program in Economics
- ix. Associate Degree (AD) Program in Business Administration

Development of Statistical Profiles of HEIs

To improve the policy outreach on related matters, PHEC identifies gaps in existing structures, collects statistics and devises frameworks. These frameworks help in developing rigorous policy guidelines and criteria to ensure provision of quality higher education across the province in accordance with the norms and policies of provincial government and the standards laid out by the Government of Pakistan.

Informed decision making is contingent upon availability of accurate and valid data from the HEIs. PHEC launched an e-portal for collection of credible data from provincially chartered private sector HEIs. The e-portal helps to collect and access updated data relating to the strength of students, faculty and programs being offered by the HEIs.

Rehnumae Markaz and Career Counseling Portal

A PC-I has been prepared to launch comprehensive project for Rehnumae Markaz and Career Counseling portal at the provincial level. The portal aims to provide guidance and help the students in colleges and universities for their career development and employability.



10. GOVERNANCE AND MANAGEMENT

Good governance is at the heart of a successful organization. It is essential for the organization to achieve its objectives and drive improvement. Good governance creates a culture of professionalism among employees and enhances job performance by ensuring satisfaction among the employees.

Commission and Accreditation Committee Meetings

Punjab Higher Education Commission meetings serve as a forum for taking decisions and formulating guidelines on various issues. PHEC acts in accordance with the decisions of its Commission. The commission is autonomous in nature and its members meet at regular intervals as laid down in its Act. A new commission was constituted in 2019 and it held two meetings.

Accreditation Committee is constituted as an independent body to review and recommend accreditation cases, inclusion of new faculties, programs and opening of sub-campuses in the private sector for approval by the commission. A new Accreditation Committee was constituted in 2019 and it held two meetings.

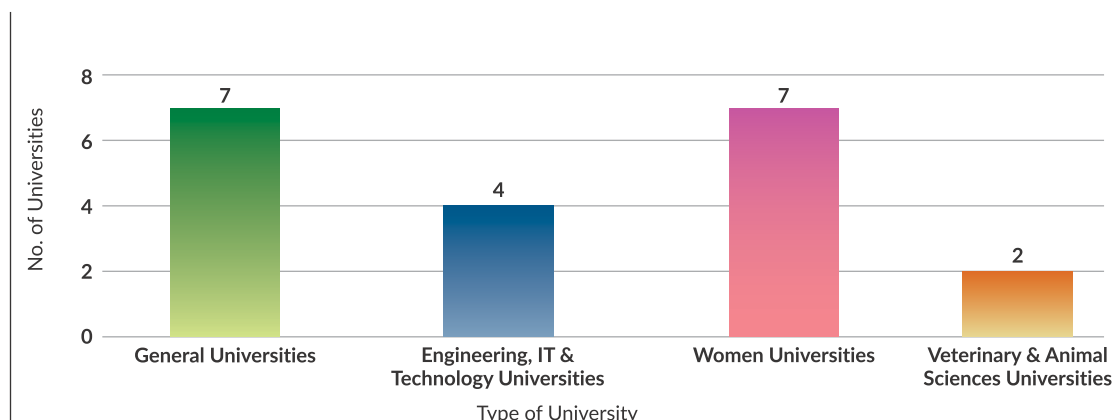


Figure 10.1: Scrutiny of Applications by Category of Universities



11. COLLABORATIONS AND LINKAGES

Academic partnerships, with both national and international organizations, help strengthen the academia and research. Such partnerships increase opportunities to benefit from the resources and expertise of partner organization. These also enhance the exposure of students, teachers and leadership regarding new innovations, ideas and solutions of the local issues.

Punjab Higher Education Commission (PHEC) has been empowered to support the linkages between institutions and industry as well as national and international organizations to support research and development in higher education. It is also mandated to promote formal links between institutions to make the most effective use of expertise and specialized equipment and promote provincial, national and international connection with respect to knowledge sharing, collaborative research, personnel exchange and cost sharing.
